THE CONSTRUCTION OF THE MUSEUM BEGAN IN 2016 AND ALLOWS FOR UNIVERSAL ACCESS, GIVING ALL VISITORS A MORE MEANINGFUL EXPERIENCE AND DEEPER UNDERSTANDING OF LADY LIBERTY'S HISTORY AND WHAT SHE STANDS FOR. IN 2018, PURSUANT TO THE TERMS OF BRIGANTI'S EMPLOYMENT AGREEMENT, BRIGANTI VESTED IN 18 MONTHS OF HIS 36 MONTHS BENEFIT. THE RULES OF SECTION 457(F) GOVERN THE TIMING OF THE TAXATION OF THE BENEFIT. ACCORDINGLY, UNDER THE RETIREMENT PLAN, BRIGANTI VESTED IN, BUT WAS NOT PAID, \$615,000 UNDER THE RETIREMENT PLAN. NONETHELESS, THE REQUIREMENTS OF SECTION 457(F) REQUIRE THAT HE BE TAXED ON THE VESTED AMOUNT IN THE YEAR OF VESTING, DESPITE THE AMOUNT NOT BEING PAID.
